The job advert was published in EraCareers on 18th May 2020, and also disseminated in iMM website and EURAXESS Portal.

The call was open from 18th May until 29th May 2020.

On the 30-31th of May 2020 the jury composed by Marc Veldhoen, Birte Blankenhaus and Bruno Silva Santos communicated to analyze the application documents (-Motivation Letter; Detailed CV; - degree certificate) in accordance to the profile and work plan indicated in the job advert.

All admitted applications were analyzed according to the following selection method, which was also indicated in the job advert:

1st Phase: CV, Motivation Letter and Research experience (70%);

2nd Phase: Interview: 30%

Curriculum, motivation letter and Research Experience (70%)

Under the Curriculum Vitae and Experience it was assigned the following valuation to each one of the criteria:

- Experience in working in a biological sciences laboratory 2 (20%)
- Experience with ELISAs (40%)
- Ability to work independently and as part of a team (10%)

The analysis and discrimination of each candidate classification in this First Phase is presented in the table of Annex II where all admitted applicants were ranked by order, from the highest to the lowest classification.

Following this, 5 applicants obtained a score equal and/or higher than 30%. In this case the applicants selected for an interview are identified below. The interview took place on June 2nd 2020.


