What iMM seeks: At this moment iMM is looking for an Accounting Administrative to join the Finance and Operations Office coordinated by Fausto Lopo de Carvalho to execute the following activities under the supervision of Sandra Duarte:

- Registration of supplier invoices in an software program;
- Record of reimbursements to be paid to employees;
- Registration of documents of various operations;
- Support to year-end accounting processes;
- Reconciliation of current accounts;
- Responsible for the update and control of accounting report files;
- Other tasks, in accumulation or not, without prejudice to the professional category and the corresponding remuneration;

Profile of Candidate

- Technical or higher education in Accounting Area;
- Minimum experience of 2 years in similar activities;
- Advanced knowledge of Excel;
- High sense of responsibility, dynamism, organizational skills and method;
- Excellent interpersonal, communication and teamwork;
- Fluent spoken and written English (mandatory);
- Good knowledge and experience with computerized accounting systems;
- Immediate availability;
- The international experience of the candidate, although not a determining criterion for selection, will be valued.

What iMM offers: iMM will offer outstanding working conditions in this area in Portugal, including a full-time contract, starting predictably in July 2022 and the possibility to work in the interface of research and research support facilities.

Working Conditions: Fixed-term employment contract; - Gross monthly salary in accordance with experience and merit of the candidate and iMM Career By-Law. The indicated amount will be subject to the mandatory taxes accordingly to Portuguese Labor Law.

The jury has the right to require to any candidate, in case of doubt, to present documents proving their statements.

International environment and experience: Diversity is a fundamental aspect of the essence of iMM, where researchers and non-researchers of different nationalities, backgrounds and areas of study work together, promoting the exchange of experiences and interactions, contributing to the personal and professional development of each person and to the existence of an international, inclusive and stimulating environment.

Pursuant to Decree-Law nr 29/2001 of 3rd February, disabled candidates shall be preferred in a situation of equal classification, and said preference supersedes any legal preferences. Candidates must declare, on their honour, their respective disability degree, type of disability and communication / expression means to be used during selection period on their application form, under the regulations above.

Evaluation Criteria: Applications will be evaluated by Sandra Duarte, Fausto Lopo de Carvalho and Cláudia Soeiro, in accordance with the following method:

1st Phase: Curricular Evaluation: 35% and Motivation Letter: 15%;

2nd Phase: Interview: 50%. Only candidates who score at least 30% in phase 1 will be selected for interview.

Results: Both admitted and excluded candidates list and final classification list shall be posted at iMM website at https://imm.medicina.ulisboa.pt/jobs/#results and all admitted candidates will be notified by email.

Preliminary Hearing and Final Decision Deadline: After notification, all candidates have 10 working days to respond. Panel's final decisions are pronounced within a period of 90 days, from application deadline.

The present call is exclusively aimed at filling the indicated vacancy and may be terminated until the homologation of the final candidates' ranking list and expires with the respective occupation of the position on offer.
