On the 17<sup>th</sup> of April 2020 the jury composed by Gonçalo Bernardes, Bruno Oliveira and Marta Marques (all PhD's), met to analyzed the application documents (-Motivation Letter; Detailed CV; - PhD certificate; - Contacts of 2 references) in accordance to the profile and work plan indicated in the job advert.

All admitted applications were analyzed according to the following selection method, which was also indicated in the job advert:

1st Phase: Curricular evaluation: 50% and Motivation Letter: 25%;

2<sup>nd</sup> Phase: Interview: 25%

## Curriculum (50%)

Under the Curriculum Vitae it was assigned the following valuation to each one of the criteria:

- PhD or PhD/MD in Biomedical Sciences (10%);
- Experience in co-supervision of junior staff (10%);
- Experience in co-management project (5%);
- Experience of at least 5 years in cancer research with relevant publications in the field (20%);
- Experience in organizing scientific meetings and promoting training activities (5%).

## **Motivation Letter (25%)**

- Motivation and interest for the activities to be performed (15%);
- Command of the written English language (10%).

The analysis and discrimination of each candidate classification in this First Phase is presented in the table of Annex I where all admitted applicants were ranked by order, from the highest to the lowest classification.

Following this, one applicant obtained a score equal and/or higher than 70%. In this case the applicant selected for an interview is identified below. The interview took place on 20 April 2020.
