

iMM is recruiting Two Early Stage Researchers under an Employment Contract - References IMM/CT/29a-2023 and IMM/CT/29b-2023

The iMM – Instituto de Medicina Molecular João Lobo Antunes is a leading Portuguese private non-profit research institute that offers a vibrant scientific environment, aiming to nurture innovative ideas in basic, clinical and translational Biomedical Research. Created in 2002, iMM Lisboa has established itself as a leading national and internationally competitive biomedical institute. Its strategy has been defined by promotion of excellence, leveraged by high-quality human resources, increasing expenditure in infrastructures and knowledge transfer to the society.

What iMM seeks: At this moment, iMM is looking for two PhD candidates to join the Gonçalo Bernardes Laboratory coordinated by Prof. Gonçalo Bernardes, under the research project ISOBIOTICS, with the reference HORIZON EUROPE – MSCA – DN – 2021 # 101072780, funded by European Union, to execute the following activities under the supervision of Professor Gonçalo Bernardes:

- Development of ¹⁸F labeling strategies through targeted isotopic modification with the goal of obtaining new approaches for isotopic labeling of biological drugs;
- Engineering of biotherapeutic proteins;
- Therapeutic/theranostic industrial applications of ²H/³H, ¹³C/¹⁴C and ¹⁸F labeled proteins.

Profile of Candidate

- Applicants must have been awarded with a Master degree in Science (Organic Chemistry/Biological Chemistry);
- Must have not spent more than 12 months in the hosting country in the past 3 years in order to comply with European MSCA-DN requirements;
- Experience in protein modification;
- Proficient in English, spoken and written;
- Team spirit, proactive attitude.

What iMM offers: iMM will offer outstanding working conditions in this area in Portugal, including a full-time contract, starting predictably in October 2023, and the possibility to work in the interface of research.

Working Conditions: - 36 months employment contract; - Gross monthly salary of 1.770,00€ plus meal allowance for each working day in the daily amount of 5,20€; holidays and Christmas allowances and mobility and family allowance (if applicable and with tax included). The amount will be subject to the mandatory taxes accordingly to Portuguese Labor Law.

Annual package per person:

- Living allowance – 34 394,40 € (includes monthly base salary, meal allowance, holidays and Christmas allowances, work accident insurance and all associated taxes payed by employer)
- Mobility allowance – 7 200,00 € (tax included)
- Family allowance – 5 940,00 € (if applicable and with tax included)

Evaluation Criteria: Applications will be evaluated by Prof. Gonçalo Bernardes, Dr. Marta Marques and Dr. Ana Guerreiro, in accordance with the following method:

- 1st Phase: Curricular evaluation: 50% and Motivation Letter: 20%;
- 2nd Phase: Interview: 30% (only candidates with over 60% classification on the 1st phase will be selected for interview).

Results: Both admitted and excluded candidates list and final classification list shall be posted at iMM website at <https://imm.medicina.ulisboa.pt/jobs/#results> and all admitted candidates will be notified by email.

Preliminary Hearing and Final Decision Deadline: After notification, all candidates have 10 working days to respond. Panel's final decisions are pronounced within a period of 90 days, from application deadline.

The present call is exclusively aimed at filling the indicated vacancy and may be terminated until the homologation of the final candidates' ranking list and expires with the respective occupation of the position on offer.
